**Location:** Synovus Bank (formally Bank of North Georgia), 10446 Alpharetta Highway, Roswell, GA 30075

**Delivery Date:** Wednesday, May 16<sup>th</sup> noon - 2:00 PM. Bring properly staged and wired art directly to the Bank of North Georgia and completed Inventory Form, waiver and application fee.

**Show Hours are Bank Hours:** Monday through Friday 9:00 AM – 5:00 PM, Saturday 9:00 AM – Noon.

**Opening Reception:** Friday, May 18, 2018. **Time:** 5:30 PM – 7:00 PM.

**Size Restriction:** The outer dimensions (exterior perimeter including frame, if applicable) should be no greater than a total of 80 inches (as in 20" x 20" or smaller combinations).

**Theme:** Open theme.

**Limit:** Three pieces (\*See Agreement #3 below). **Price:** No price restriction

**Application Fee:** \$25.00. Proceeds go towards RFAA's major philanthropic commitment, the North Fulton Invitational High School Art Show .

**Prizes: People's Choice and \$50 prize, 2 Honorable Mention Ribbons** (voted on by reception attendees)

**End of Show Pick-up:** Friday, June, 22nd, between the hours of 12:00 and 2:00 PM. Pick-up art at the Bank of North Georgia. All remaining works after 2:00 PM will be transported to ACE gallery for pick-up by the artist at a later date.

**Artist agrees:**

1. To be a member of RFAA in good standing.
2. All Submitted work must be for sale, two dimensional in nature, be original art (no prints or giclee), gallery wrapped (at least 1" thick canvas with finished edges) or framed, completed within the last 3 years and **'WIRED'** for hanging. Medium may include the use of pencil, oil, acrylic, watercolor, pastels, collage and mixed media. No computer-generated art will be accepted. RFAA/Show Curator reserves the right to deny any entry due to controversial subject matter or improper staging.
3. The Bank will keep track of sales and will notify the show coordinator, Arlyn Huntzicker, of the sale. The artist will be notified immediately so **the artist may replace a sold piece** with a similarly sized piece that also fulfills the prospectus requirements.
4. The Bank will hold monies from sales and transfer them to RFAA Treasurer. A 20% commission on the sales price will be kept by RFAA and the remaining 80% of the sales price will be paid to the artist when the Treasure makes a full accounting at the completion of the show. No prices will be changed during the show.
5. Registered work will remain through the entire show unless purchased. An artist who removes art early will be charged a 20% commission fee by RFAA.
6. To volunteer for 3 hours of Gallery sitting at ACE.
7. Read and sign Roswell Fine Arts Alliance Waiver of Liability found on the RFAA website.
