The Roswell Fine Arts Alliance is pleased to announce that the Annual Members' Juried Show, Genesis XXVI, will be virtual this year. Much behind-the-scenes technology is necessary to create this show which contributes to the time between registration and the actual event.

## **Online Registration: Saturday, August 15, to Sunday, August 23, (by midnight)**

- Submit one or two paintings virtually to Patty DelValle at: [patty@pattydart.com](mailto:patty@pattydart.com). JPEGs need to be at least 800 pixels or using the largest possible file size (full/actual size). Do not take photos of paintings under glass. Crop photos so that only the painting is visible. Should the purchaser wish to see the piece with mat or with mat and frame, plan to have these photos available to send during negotiation.
- There is no size or price limit for art submitted virtually.
- There is a **\$20 entry fee** whether 1 or 2 entries are submitted. Proceeds help support the annual RFAA High School Show in January, our premiere 501(c)3 non-profit status event.

**Juried Selection.** Our judge, Joseph Peragine, Professor of Painting and Drawing at Georgia State University, will select the works accepted for the show, and the seven prize winners. Any comments, if offered by the judge, will be shared with the artist privately.

**Notification.** You will be notified by September 6, by text, email or phone, if any of your pieces are not accepted. Non-acceptance is not a reflection on your artistic ability but rather a reflection of the judge's impressions of your work in relation to other entered works. If you are **not** contacted, you may **assume** both your pieces have been accepted into the virtual gallery. *Entry fee will not be refunded if your work is not accepted into the show.*

**Show Dates and Time: September 10 – October 30, 2020.** Art will be available for viewing and purchasing, by visiting the club web page [www.rfaa.org](http://www.rfaa.org) and clicking the link GENESIS SHOW. Unfortunately, there will be no wonderful reception this year due to circumstances beyond our control.

**Sale's Procedure.** All submitted work must be for sale. The show curator will inform the artist of a sale. *The artist is responsible for communicating with the purchaser concerning payment and delivery of the art. The artist is responsible for any shipping costs.* The artist will receive 80% of the proceeds with RFAA receiving 20% for facilitating this event. It is the artist's responsibility to submit any sales tax due the State of Georgia.

**Eligibility:**

- Only RFAA members with currently paid dues may submit entries.
- **Only 2-Dimensional Original works will be accepted.** Mediums may include oil, acrylic, watercolor, drawing, pastels, collage, and mixed-media.
- No photography and computer-generated art or reproductions will be accepted.
- Paintings completed under the tutelage of a workshop or class instructor will not be accepted.
- All entries submitted must have been **completed within the past three years.** Entries may have been accepted in other RFAA shows but not a prior Genesis show.
- Because of the public nature of the venue, we ask that no human nude artworks be entered. The Genesis XXVI curator maintains the right to deny any entry due to controversial subject matter, age, improper staging, or condition.
- ***All entries must be for sale and remain on display until the show concludes, unless sold within the confines of this show. A commission fee of 20% will be retained by RFAA on any piece sold. If a piece is removed from the show by the artist for any reason prior to the completion of the exhibition, it is the responsibility of the artist to pay the 20% commission fee.***
